Revised instructions post-enhancement

- 1) Regular members who have completed / not completed 10 years of service in RBI will be eligible for a loan limit of Rs.60,00,000/-Rs.40,00,000, respectively.
- 2) Entire loan of the regular member should be within the Cap of 50 times of Gross salary or the above at 1, whichever is lower.
- 3) For members whose service is less than 5 years in RBI, they will have to submit the latest PF. Superannuation & Banks loan statements (with accrued interest certificate) along with the loan application, irrespective of the quantum of loan applied.
- 4) However, in order to avail the enhanced limit i.e. between Rs.40 lakh to Rs.60 lakh members will have to submit the statements indicated in 3 above., Moreover, perquisites should necessarily be credited to the Society's a/c and the purpose of the loan should be Housing / Education.
